ECONOMIC RECOVERY BRIDGE PROGRAM

- [H.315 \(Act 9\)](#) became law on April 17 and established the framework for the Economic Recovery Bridge Grants program.
- \$10,000,000 of American Rescue Plan Act dollars were allocated to the program.
- ACCD worked with the legislature to establish basic parameters and guidelines for the grant program
- Primary goal of the program is to provide funding to businesses and non-profits who have been previously unable to access federal or state assistance;
- Secondary goal of the program is to provide additional financial support to businesses who have not already received adequate funding via federal or state programs.

ECONOMIC RECOVERY BRIDGE PROGRAM

- H.439 (“Big Bill”/Budget Bill) passed both the House and Senate on May 21st
- *When signed by the Governor/when the bill goes into law:* \$20,000,000 of additional American Rescue Plan Act funding will be allocated to the Economic Recovery Bridge program.
 - This legislation directs ACCD to prioritize funding for impacted Tourism, Travel & Hospitality businesses.

TOTAL FUNDING: \$30,000,000 (ARPA \$\$)

ECONOMIC RECOVERY BRIDGE PROGRAM

So, What's Different?

- ACCD has previously evaluated applications based upon revenue declines between 2019-2020 – this application is based on an applicant having a reported net loss on their federal 2020 tax return to be eligible; **AND**
- The amount of the award is capped based upon the net-loss reflected in the sum of an applicant's P&L statements for the period from March 31, 2020 – April 30, 2021.

Rather than a percentage of revenue decline (iteration 1 & 2), awards will be calculated as 3x the applicant's fixed business expenses for a single month in the March 31, 2020 – April 30, 2021 timeframe.

GUIDELINES

APPLICATION PROCESS

- **APPLICATION OPENING DATE:** Monday, June 7th, 2021 @ 9:00AM
- Applicants will input their required information into the online application portal provided by the Agency of Commerce and Community Development and submit the application, along with all required documents.
- Reviewers from the Agency of Commerce and Community Development, and other partners, will review applications on a first-come first-served basis within using the priority criteria described below. Reviews will include cross-checking data fields and verifying the required documentation to either approve, deny, or return the application for more information and/or correction.

GUIDELINES

Who is Eligible?

Eligible businesses must meet all of the below criteria in order to access Economic Recovery Bridge Grant Funds. The business:

1. Must be domiciled, or have its primary place of business in Vermont; **AND**
2. Be organized and operated:
 - a. On a for-profit basis, including a sole proprietor, partnership, LLC, business corporation, cooperative, or mutual benefit enterprise; **OR**
 - b. On a non-profit or low-profit basis, including a mutual benefit corporation, public benefit corporation, and a low-profit limited liability company; **AND**
3. Be open at the time of the application; **OR**
 - a. Be closed at the time of application due to the COVID-19 public health emergency but have plans to re-open; **AND**
4. Be in compliance with current State health and safety protocols established by the Vermont Forward Re-Opening Plan; **AND**
5. Able to demonstrate that the business experienced a net loss in 2020, greater than any net loss reported in 2019, via submitted federal tax returns; **AND**
6. Be in good standing with the Vermont Department of Labor (if applicable, to be confirmed by reviewers); **AND**
7. Be in good standing with the Vermont Secretary of State (if applicable, to be confirmed by reviewers); **AND**
8. Be in good standing with the Vermont Department of Taxes; **AND**
9. Not currently be in Chapter 7 bankruptcy;

GUIDELINES

What Do Documents Do I Need For My Application?

Eligible businesses will be required to provide the following information in their grant applications:

- A Duns & Bradstreet (DUNS) number (*see next slide*)
 - (*businesses can obtain a FREE DUNS number here: <https://fedgov.dnb.com/webform/>*)
- Federal Employer Identification Number (FEIN) or Social Security Number (sole proprietors only);
- The North American Industrial Classification System (NAICS) code for the applying company;
- Monthly P&Ls for the period from March 2020 through April 2021, which are used as the basis for calculating net income;
- Information about any compensation or assistance an applying business has received or applied for from:
 - o the Federal Paycheck Protection Program (PPP) loans in 2020 or 2021 and the amounts forgiven;
 - o Economic Injury Disaster Loan (EIDL) advances (grants);
 - o Any other direct federal or state grant funds for economic damages incurred as a result of COVID-19 in 2020 and 2021;
- State and Federal Tax Returns for 2019 **and** 2020;
- Uploads of one month of invoices for the following fixed monthly expenses:
 - o Commercial mortgage or rent;
 - o Business insurance;
 - o Electricity;
 - o Heat, Water, Sewer service;
 - o Telecommunications services (phone service including landline, cellular and business-related cable service); and
 - o Internet service.

GUIDELINES

What is a DUNS Number & How to Acquire One

A DUNS number is a unique, non-indicative 9-digit identifier issued and maintained by Duns & Bradstreet (D&B) that verifies the existence of a business entity. Businesses must have a DUNS number to apply for an award because it is American Rescue Plan Act (ARPA) funded program.

STEP 1: OBTAIN A DUNS NUMBER

Follow the webform here: <https://fedgov.dnb.com/webform/> to obtain a FREE DUNS number. Your address must be consistent with the Vermont Secretary of State record. If you do not already have a DUNS number, one can be obtained usually in one or two business days.

STEP 2: REGISTER YOUR DUNS NUMBER

Once you have your DUNS number, you will need to register it in the System for Award Management (SAM). SAM is a free government operated site. To register in SAM, to www.SAM.gov

GUIDELINES

Newly Purchased, Newly Created & Closed Businesses

- Newly opened or newly purchased business are eligible for the program as long as the business can show a tax loss for 2020.
- The only difference in the application is that you **will not be required** to provide tax returns for 2019 and will only provide Profit and Loss statements for those months that you were in business or making payments on your operations.
- Businesses who have been temporarily closed because of COVID-19 can apply for an Economic Recovery Bridge Program award and will be asked for a written description of its good-faith plan to reopen will be required when applying.

GUIDELINES

Initial 30-Days: Priority Applicants

Within the first 30 days of grants being accepted first priority grant awards will be issued to applicants who meet all of the below criteria:

- The business has not received, and does not have a pending application for any State or Federal financial assistance in 2020 or 2021 (this includes, but is not limited to):
 - o Paycheck Protection Program loans and Grants;
 - o Economic Injury Disaster Loans and Grants;
 - o Any other direct financial assistance provided by Coronavirus Relief Funding or ARPA Funding including:
 - Vermont Economic Recovery Grant;
 - Sole Proprietor Stabilization Program Grant;
 - Healthcare Provider Grants;
 - Restaurant Revitalization Grants Funding;
 - Shuttered Venue Grants;
 - Vermont Agricultural Grants;
- The business suffered a net-loss in 2020, as shown on a federal tax return

GUIDELINES

Second-Tier Priority Applicants & Criteria

After the 30-day initial grant application window, the Agency of Commerce and Community Development will continue to give first priority to applicants that have not received prior assistance, however, at this point, businesses who suffered a 2020 net tax loss, and still can demonstrate a net loss after adding back the amounts of assistance received in 2020 and 2021 will be eligible.

Added-back assistance includes:

- Non-taxable State or Federal financial assistance (includes, Paycheck Protection Program forgiven loans, Economic Injury Disaster Grants, and any other nontaxable direct financial assistance provided by Coronavirus Relief or ARPA Funding)

GUIDELINES

Third Tier Priority Applicants & Criteria

Business that have applied for Restaurant Revitalization or Shuttered Venue assistance will be placed in a third priority category. In order to prevent duplication of benefits, applicants who have applied for RR or SVO, will not have their Bridge Program application processed until a decision is made on those pending applications.

However, if after financial assistance is received from RR or SVO, and a business still shows an adjusted net-loss, Bridge Grant applications will be processed and awarded to the extent of the remaining adjusted net-loss.

GUIDELINES

Grant Award Formula

The amount of the grant will be calculated as:

Three times the sum of fixed monthly expenses as evidenced by the uploaded invoices.

The eligible business's fixed monthly expenses include (as determined by the uploaded invoices):

- Commercial mortgage or rent;
- Insurance, electricity;
- Heat, water;
- Sewer service;
- Telecommunications Service; and
- Internet service.

However, grant awards shall not exceed the lesser of:

- The applicant's remaining adjusted net loss after the addition of non-taxable prior assistance; **OR**
- \$150,000

This award will be used to cover business expenses associated with the Coronavirus Pandemic of 2019 (COVID-19) disaster, in connection with section 601 of the Social Security Act, as added by section 5001 of the Coronavirus Aid, Relief, and Economic Security Act, Pub. L. No. 116-136, div. A, Title V (Mar. 27, 2020) ("section 601").

Mo's Test Business must repay the award or portion of the award to the ACCD if: any award funds received were issued in error; are based on incorrect representations made to the ACCD; have been used for activities other than supporting the applicant business; or any demonstrated loss forming the basis of an award under this program are covered by other federal grants or federally forgiven loans received by Mo's Test Business. I agree that the final determination of whether there has been a duplication of benefits and the amount to be repaid, if any, will be made by ACCD.

Mo's Test Business understands that, if Federal guidance on the regulations of State Fiscal Recovery (FSR) funding changes, it may change the terms of this award.

Mo's Test Business shall maintain and make available to the State of Vermont and/or United States Department of the Treasury, upon request, all documents, and financial records sufficient to establish compliance with subsection 601(d) of the Social Security Act, as amended, (42 U.S.C. 801(d)). Records must be maintained for 5 years after final payment is made using State Fiscal Recovery Funds. Records to support compliance with subsection 601(d) may include, but are not limited to, copies of the following:

- a. General ledger and subsidiary ledgers used to account for (a) the receipt of State Fiscal Recovery Fund payments and (b) the disbursements from such payments to meet eligible expenses related to the public health emergency due to COVID-19;
- b. Income and Budget records for 2019, 2020, and 2021;
- c. Contracts and subcontracts entered into using State Fiscal Recovery Fund payments and all documents related to such contracts;
- d. Grant agreements and grant subaward agreements entered into using State Fiscal Recovery Fund payments and all documents related to such awards;
- e. All documentation of reports, audits, and other monitoring of contractors, including subcontractors, and grant recipient and subrecipients;
- f. All documentation supporting the performance outcomes of contracts, subcontracts, awards, and subawards;
- g. All internal and external email/electronic communications related to use of State Fiscal Recovery Fund payments; and
- h. All investigative files and inquiry reports involving State Fiscal Recovery Fund payments.

To the best of my knowledge, neither Mo's Test Business nor Mo's Test Business's principals (officers, directors, owners, or partners) are presently debarred, suspended, proposed for debarment, declared ineligible or excluded from participation in Federal programs, or programs supported in whole or in part by Federal funds.
