## Introduction

This 2010 Registry and Mobile Home Parks Report comprise the statistics and findings of the Department as required to be submitted to the Legislature.

In the three years following our 2007 Mobile Home Parks Report, the economy had the worst economic downturn since the Great Depression. The impact on Vermont's housing market was not as severe as many other states, but foreclosures doubled and home prices declined. Unemployment was lower than the national average but reached more than seven percent in the early half of 2009. Frozen financial markets meant that nonprofit housing organizations were not able to get financing to purchase any mobile home parks that came on the market.

On a positive note, in the past three years no new park closure notices were issued.

Although park sale activity was slow, significant legislation was passed related to mobile home financing and making major changes to the mobile home park statute. Two bills supported by the Department (H.331 and H.332) were incorporated into Act 176 which was enacted in 2008. H.331 allows some mobile homes to be financed and titled as real property increasing the availability of affordable financing for mobile home owners in Vermont. With its passage most of the major recommendations of the 2006 Governor's Advisory Commission have been implemented. By requiring a park sale notice before an owner can close a park, H.332 gave residents of mobile home parks slated for closure the opportunity for a nonprofit to buy their park and preserve it as affordable housing.

Another important piece of legislation was enacted in 2010. Act 140 revised the Mobile Home Uniform Bill of Sale and clarified laws related to "rent-to-own" agreements. As a result no mobile home resident will be stuck in a situation where ownership of the mobile home and the responsibility for making any repairs are not clear.

The Department's Mobile Home Park Program converted to a new Internet based database and online park registration service. Due to staff reductions, the Department contracted with Vermont Information Consortium, the official eGovernment partner for the State and host of the State's website Vermont.gov to develop this service. In 2009 registrations were received by mail and data entered by the Housing Program Coordinator. The service includes the lot increase database and the Department plans to add park sales and closure notifications in the near future. In 2010 fifteen percent of mobile home parks self-registered and paid the lot fee online.

The Department also continues to provide the First Stop Grant to the CVOEO Mobile Home Project which provides statewide direct assistance to mobile home residents.

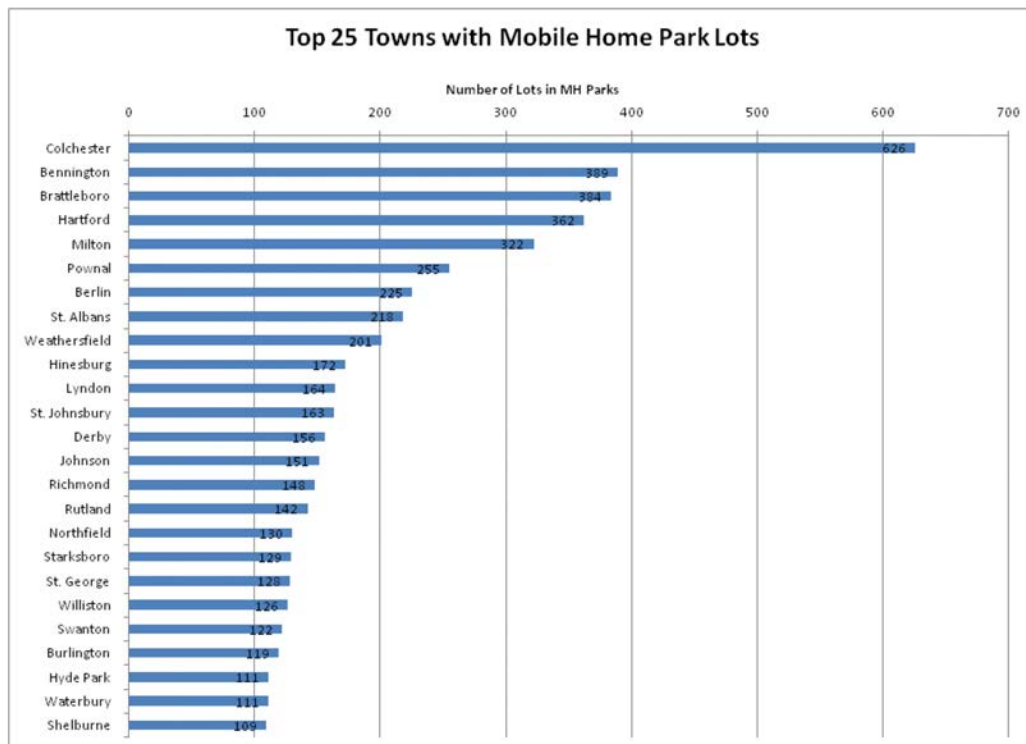

## NEW HUD RULES

Vermont is one of about a dozen States that does not participate in HUD's State Administrative Agency program. This means that HUD is responsible for enforcement of HUD's manufactured housing rules in Vermont.

HUD's Model Manufactured Housing Installation Standards Rule became effective on October 20, 2008. This rule only applies to the initial set up of new mobile homes. The mobile home dealer or retailer or distributor is responsible for ensuring proper set up. HUD regulations for installation and set up do not require cement pads. A few Vermont towns have zoning ordinances regulating foundations, and some lenders may require a pad before they will finance a mobile home.

HUD's dispute resolution program became effective on February 8, 2008. The purpose of this program is to resolve questions between manufacturers, dealers and installers of responsibility for defects in new manufactured homes reported within one year of installation on a voluntary basis outside of the regulatory environment. Information about this program is provided with any new manufactured home.

## MOBILE HOMES LOCATED IN FLOOD HAZARD AREAS<sup>1</sup>

Many Vermont mobile home parks are located in lower areas and are partly or completely in a flood zone. The minimum requirements of the National Flood Insurance Program are that the lowest floor of any replaced or substantially improved mobile home in a park located in a flood zone must be at or above Base Flood Elevation, but allows raising the home only 36 inches above grade. The Vermont DEC recommends that towns have regulations that locate the lowest floor of any replaced or substantially improved mobile home at least one foot above the base flood elevation. A new or replacement mobile home in a flood hazard area must also be securely anchored to an adequate foundation or pier system to prevent the home from floating or capsizing. The cost of meeting these requirements can be substantial, and many mobile home residents do not have flood insurance.

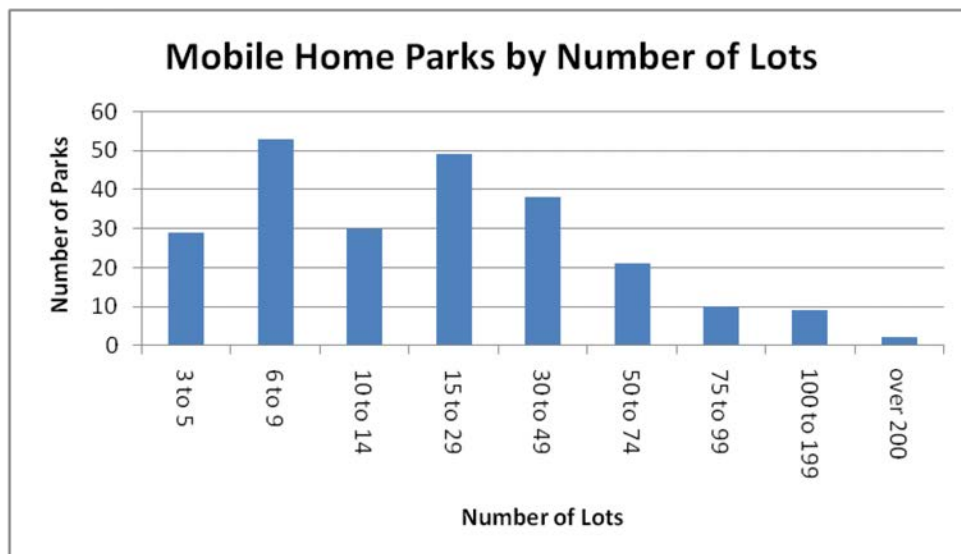

## Park Sales

There were 30 park sale notices issued from 2008 through 2010. Five parks sold and all the sales were to for-profit investors. All attempts by nonprofits to buy mobile home parks resulted in the decision not to proceed in almost every case because no financing was available. Two parks were also sold at foreclosure sales by banks, and two others were sold from parents to a child. Near the end of 2010 things appear to be improving and one nonprofit reached a purchase agreement to acquire a significant mobile home park in Chittenden County. However, the fact that most Vermont mobile home parks are small and many have aging or inadequate infrastructure still makes it difficult for nonprofits to acquire these parks, and financing them is still problematic.

Another development was the change in the park sale notice law requiring a sale notice before issuing a closure notice. Unfortunately, the Rockingham Area Community Land Trust (RACLT) had to make the difficult decision that the Bunker Hill Mobile Home Park in Windsor will be closed, and issued the required Notice of Intent to Sell in late September 2010. The mobile home owners have exercised their right under the new law to consider buying the park as a group and have begun to explore the possibility of forming a housing cooperative with the assistance of the CVOEO Mobile Home Project.

The inability of nonprofits to buy parks, coupled with the situation of Bunker Hill, triggered a renewed interest in creating mobile home park cooperatives in Vermont. In neighboring New Hampshire, the New Hampshire Community Loan Fund, which has been instrumental in creating over 90 mobile home park cooperatives, launched ROC-USA (Resident Owned Communities) in May 2008. Through a network of certified technical assistance providers (TAP), ROC-USA has assisted with the creation of 20 new mobile home park cooperatives in nine states. The CVOEO Mobile Home Project has helped connect the Bunker Hill residents with the Cooperative Development Institute in Massachusetts which is the preferred ROC-USA certified TAP for Vermont.



## **Park Closures**

This report does not include any new park closure notices; however the Department is aware of several very small parks, including four parks that have only two occupied units. These parks remain in the Registry because the property still meets the definition of being "laid out or adapted to accommodate" more than two mobile homes and the owners have not issued any park closure notice. The Department will ensure that the rights of the few remaining residents are upheld and advise the park owners when requested. Two of these park owners did request park closure forms. The Gevry Mobile Home Park in Vergennes is for all intents and purposes closed with over a dozen empty mobile homes and is likely to be sold for re-development of affordable housing.

The future of Shelburnewood Park continues to be uncertain. An ambitious development plan by the Housing Foundation Inc. (HFI) in concert with a private developer fell through largely due to complications or delays getting local planning and permitting approval. As a result of the termination of the purchase and sale agreement, the closure notice issued in 2005 was reactivated in March 2010 with evictions possible in December 2010 if the park owners decide to close the park. The Department has spent a considerable amount of time advising the park owners' through their attorney on the requirements of park sale and closure notices that may be triggered depending on how the owners ultimately decide to move forward. Currently the owners are exploring all options including keeping the park open or closing it under certain conditions and have not made any decisions.

As the residents of Bunker Hill pursue the idea of forming a cooperative to buy their park, RACLT is also looking into applying to the Vermont Community Development Program for a CDBG relocation grant if the park closes.

Three parks that were slated for closure in the 2007 report all closed by the end of 2008. These parks were Fuller's, Mitchell's, and Mountainside Meadow.

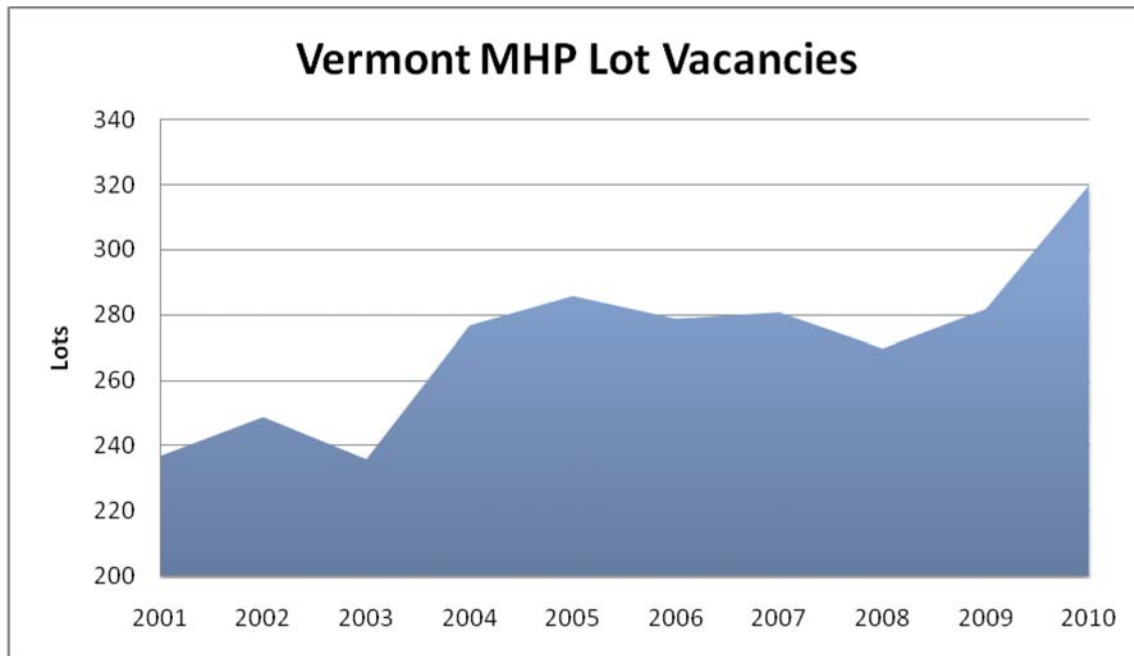


## Vacancy Rate

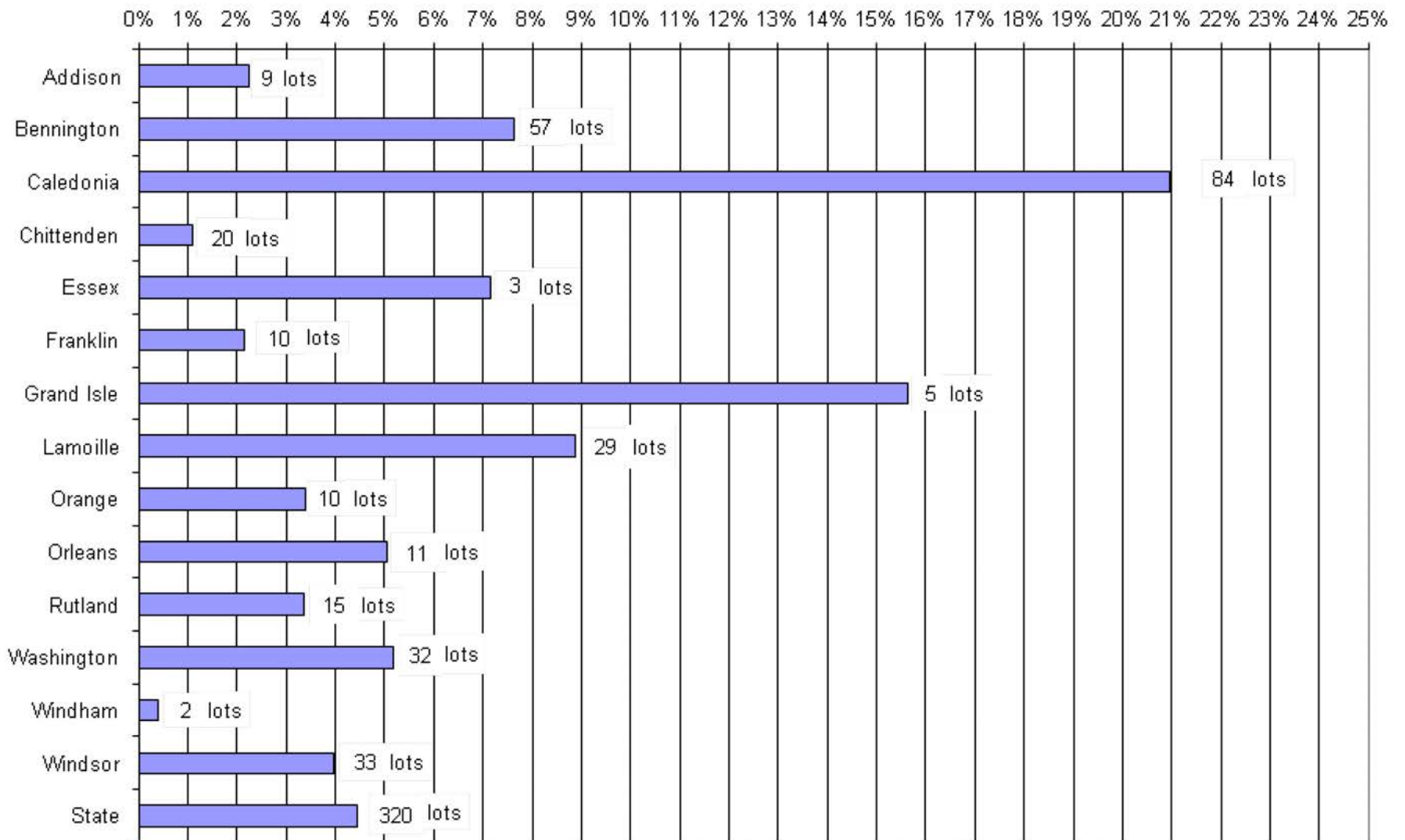
After hovering between 3.7 – 3.9% for several years, in 2010 the vacancy rate rose to 4.4%. 320 lots were reported as vacant and available by park owners, a sharp increase of 38 lots in one year. The number of parks with any vacant lot was 83 parks, an increase of 13. 38 parks reported an increased number of vacant lots versus 17 parks that reported fewer vacant lots compared to last year.

Vacant lots are concentrated in a few parks and two-thirds of all parks are full. Of the 245 parks in the state, 154 or 48% of all vacant lots are located in ten parks.

The number of leased lots decreased by 47 lots due to increased vacancies and other lots not rented for one reason or another. Park owners have reported anecdotally that there has been an increase in abandoned mobile homes and mobile homes repossessed by banks.



## 2010 Mobile Home Park Vacancy Rates

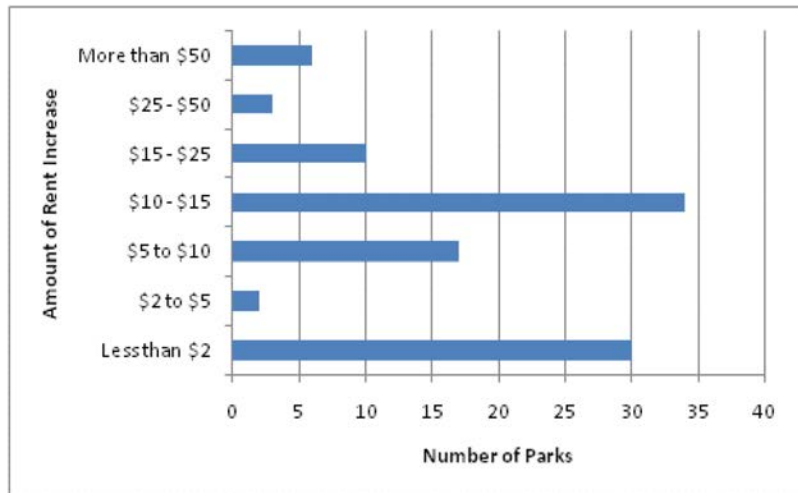


## Lot Rent Increases

Due to the recession and decline in the housing market, the housing component of the consumer price index (CPI) decreased for the year ending August 2009 and again for August 2010, and the threshold for mediation requests was very low at 0.4 percent in 2010 and 0.6 percent for 2011. By comparison, the average threshold over the previous decade was 3.5 percent. The threshold is the percent of increase that, if exceeded, gives the leaseholders a right to challenge the increase.

Because any increase more than about \$1 could potentially face opposition, many mobile home park owners decided not to issue any rent increase in 2010. Only 77 parks raised rent in 2010. Out of 102 rent increase notices affecting those parks (some parks have more than one tier of rent), 30 raised the rent less than \$2. Most of the remaining increases were \$5 to \$15. This trend appears to be continuing in 2011 as only 29 parks raised the lot rent in January, compared to 45 parks that raised the rent in January of 2008 and 2009.

There were six mediation requests in 2008 and two in 2009. In 2010 there were also two requests for mediation. One of these disputes concerned a \$50 increase that settled with the rent going up by \$38.50 with most of that representing water and sewer charges that residents had been paying separately but will be



included in the rent from now on. The other mediation was a \$19 increase that was settled with the rent going up by \$5. The park had been sold to a new owner in 2005 and had experienced increases totaling about 45% since the sale. In addition to agreeing on the lot rent, the park owner will address some maintenance issues with the park.

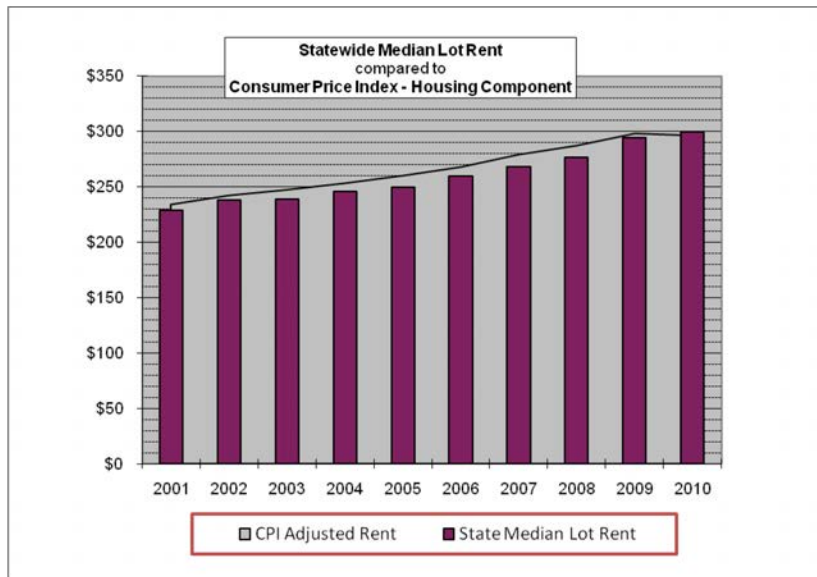
A dispute over a May 2009 rent increase that went to Court was also settled in 2010. At issue was a proposal by a new owner of the park to raise the rent by 58% to \$250. Mediation was not successful and a majority of leaseholders petitioned the Court to rule that the lot rent increase was "clearly excessive" as defined in the mobile home park statute. The resulting settlement called for lot rent to be set at \$185 beginning in August 2010 and mostly limits increases to the mediation threshold for a period of five years. Partial rent funds held in court escrow for the period when the increase was in dispute from May 2009 through July 2010 were disbursed to the leaseholders who joined the lawsuit.

## STATE AND COUNTY MEDIAN LOT RENT

Eighty-seven parks increased lot rent from October 2009 to October 2010 and the State median lot rent increased from \$294 to \$300. The median is the mid-point meaning half the lots in the state have rent below \$300 and half above.

There are twelve mobile home parks in the state that reported no lot rent because the park owner owns all of the mobile homes in the park and just rents out mobile homes.

County Median Lot Rents ranged from \$200 in Lamoille and Orleans Counties, to \$349 in Chittenden County. Seven Counties had increased median rent from 2009 to 2010. Essex County and Grand Isle County each have only two mobile home parks, so the County Median is equal to the lot rent of the larger of the two parks in the County. In Essex County the lot rents of the two parks are \$160 and \$215 and in Grand Isle

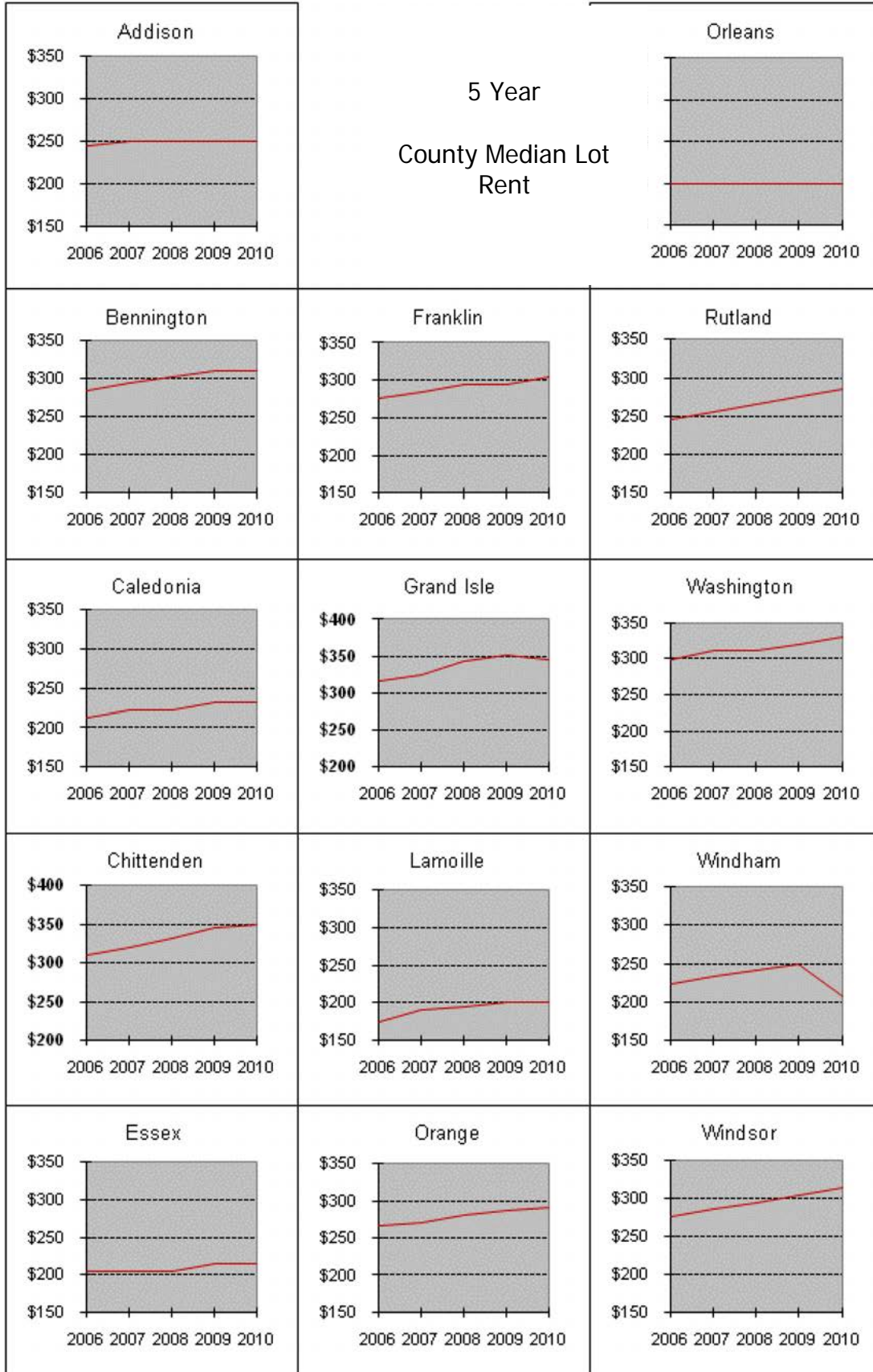


County the lot rents are \$180 and \$346. The County Median in Grand Isle County went down due to a Capital Improvements Surcharge that expired at Cooper's Bay MHP lowering the rent. The Windham County Median Rent also dropped from \$249 to \$207 because Mountain Home Park with 276 lots has more than half of the lots in the County. The lot rent at Mountain Home Park was reduced due to the Town water and

sewer charges being removed from the lot rent. Each mobile home owner is now billed individually for the water and sewer.

The law allows parks to have different levels of rent for some lots in a park if the park owner has a reasonable basis to categorize the lots, for example larger lots for double wide homes or more improved lots with cement pads. New lots in expanded parks can also have higher lot rent. Only 37 parks have more than one tier of rent and 375 lots in parks have a rent different than the "standard lot rent" for the park. The official State median lot rent is calculated using only the standard lot rent; however, including these other tiers did not actually change the median.

## Mobile Homes Moved

The report on mobile homes moved gives an indication of how many people are buying, selling or replacing mobile homes. Fewer mobile homes were moved in or out of parks during the recession. From 2009-2010 82 mobile homes were removed from parks, and 59 mobile homes were moved into parks. From 2008-2009 81 mobile homes were moved out, and 70 were moved in. From 2006-2007 108 moved out and 96 moved in.

## PRE-HUD CODE MOBILE HOMES

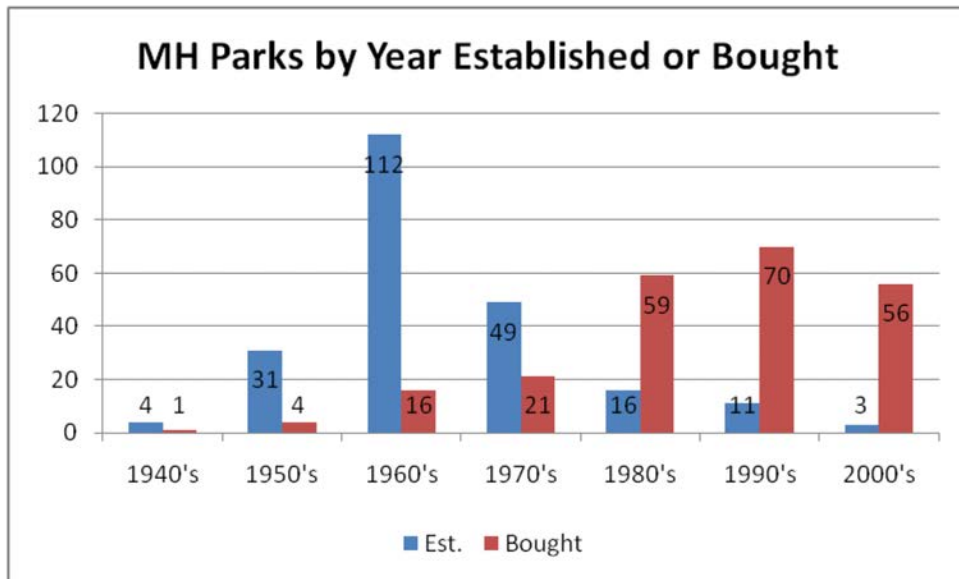
Pre-1976 mobile homes were built before the HUD code which established minimum standards for health and safety of these homes and before current energy efficiency standards. There are many of these homes still in use in Vermont mobile home parks due to the fact that most Vermont parks were built in the 1960's and mobile homes are not often moved. However, unless they have been meticulously maintained and substantially upgraded, they are unlikely to meet today's standards.

For good reasons, park owners are allowed to have reasonable aesthetic, and health and safety standards for homes to remain in the park, but the Department's Housing Division Rules do not allow a park owner to require removal of a home solely due to its age. A few parks have energy efficiency requirements. If the park owner applies these standards to resale of mobile homes to remain in the park, pre-HUD Code homes will have to be removed from the park if they are sold.

The lack of financing for mobile homes is severe, but for single wide pre-HUD Code mobile homes financing is virtually non-existent. When these mobile homes are sold it

is for cash or on a 'rent to own' basis or they may be turned into rental units. Act 140 ensures that people moving into these units have the right legal protections.

If an individual owns the mobile home they are responsible for maintenance, but could be eligible for home improvement loans or grants, weatherization etc. If the person does not meet all the conditions of ownership they are considered a renter, and the mobile home owner can be held responsible to comply with rental housing safety, and the renter can easily understand that they are protected by the landlord-tenant laws.
