V. Conflict of Interest and Open Meeting Review (Max Krieger)

 Maxwell Krieger, general counsel for the Agency of Commerce and Community Development, provided an overview of the responsibilities of the commissioners, public meeting laws and rules, conflicts of interest, and other legal matters pertinent to the Vermont 250th Anniversary Commission.

VI. Draft Text: Introductory Outreach Presentation (Alexandria Piper))

• The draft text for the Introductory Outreach Presentation was emailed to Commissioners prior to the meeting and was uploaded to the 250th Commission Microsoft Teams site. The text was prepared by Alexandria Piper, with whom the State contracted per the direction of the 250th Commission. This text along with images in a PowerPoint and/or video will be used for outreach and at community presentations. Commissioners were asked review the document and provide any comments or edits using track changes prior to the next meeting. The contract with Ms. Piper was also posted on the Teams site.

VII. Project Proposal: K-12 Teacher Training Workshop in Place-Based Education "Freedom and Unity: The Struggle for Independence on the Vermont Frontier

• The project proposal, prepared by Angela Labrador, was sent via email to Commissioners prior to the meeting and posted to the 250th Commission Microsoft Teams page. At the May 23, 2022 meeting, the Commission passed a motion to enable the chair to spend up to \$10,000 to continue and augment the work Ms. Labrador did two summers ago with the K-12 teacher training "Freedom and Unity." The proposal is \$12,000 and is being presented to the Commission for consideration. Questions relating to the format of funding grants were raised. It was determined that Commissioners should review the proposal, which will be discussed at the next meeting. Ms. Trieschmann notified Ms. Labrador that the Commission is still reviewing her proposal.

VIII. Education Committee Updates

Vermont Alliance for Social Studies Conference
 Mr. Holland announced that the Vermont Alliance for Social Studies
 Conference took place last week in Montpelier and was the first annual conference in four years. The conference was well attended with 150 teachers.
 The theme was "Imagining the 250th and beyond," presented by several

members of the Commission and Committee. Twenty-eight teachers signed up to receive emails about the 250th commemoration efforts. There were several discussions surrounding teaching materials, funds for field trips, and professional development. Mr. Spivak added the committee would like to immediately send a short list of resources to teachers to promote involvement and excitement, as well as convene a listening session for teacher feedback.

IX. Strategic Planning

• Katie Bockwoldt, Chief Performance Office, provided an overview of the completed Strategic Plan resulting from the discussions during the two Commission Strategic Planning meetings. The final Strategic Plan was uploaded to the Vermont 250th Microsoft Teams site.

X. Committees and Governance

• Katie Bockwoldt, Chief Performance Office, provided an overview of the summary structure of the Commission's committees and governance. The final Committee Structure and Governance was uploaded to the Vermont 250th Microsoft Teams site.
